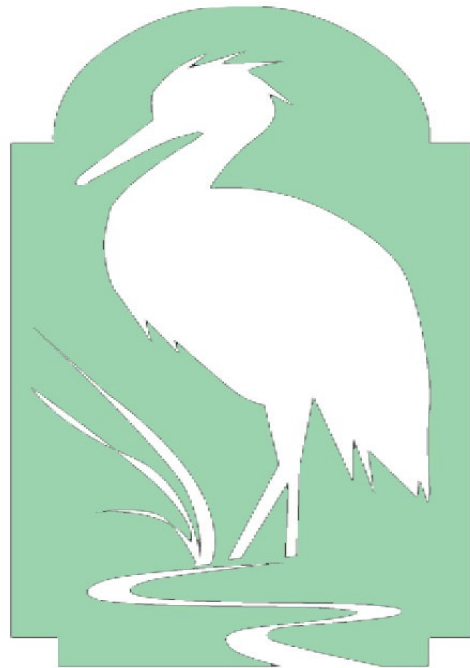

*Tournament balances are due on the date of the tournament. All Food choices will need to be decided 14 days prior to tournament for ordering purposes.*

*We post flight all tournaments unless you prefer another method*

*We provide the following; Staff Support, Score Cards, Score Sheets, Scoring, Cart Signs, Announcements, Pairings, Closet to the Pin, Longest Drive & Flighting*

*All Shotgun Tournaments must have a Minimum of 72 Players*

*Holes for Closest to the pin: 3,5,8,11,16*

*Holes for Longest Drive: 1,6,14,15,17,18*

### **FACILITY FEE:**

DEPOSIT: A deposit of \$300.00 is due to reserve the Date (this will be posted towards the tournament)

REMAINING BALANCE: All balances are due the day of the Tournament. 90 days (from signing contract) written cancellation of event is required to obtain the return of your deposit.

VOLUNTEERS/TOURNAMENT STAFF: An extra 4 carts will be available for the tournament staff use during this time, if more carts are needed, their will be charge of \$100.00 per cart.

FOOD AND BEVERAGE INFORMATION: Outside Food & Beverage is Allowed. (Room Rental Required) Alcoholic Beverages: You are required to have get a One Day ABC License

ALCOHOLIC BEVERAGE SERVICE: As a licensee of the State Alcoholic Beverage Control Authority, this Club strictly adheres to all laws and regulations pertaining to service and sale of alcoholic beverages. We ask your understanding and must insist upon your cooperation in preventing sales to minors or intoxicated persons.

GUARANTEE: An estimated attendance figure is to be provided at the time the function is scheduled. A final minimum guarantee of attendance must be provided (14) fourteen business days before the event, and once received may not be reduced. The minimum guarantee is used to purchase supplies and schedule staff, therefore, that number is the minimum number that you will be charged for, if fewer guests attend. If more guests attend, additional charges will be made for the number actually served over the guarantee. If a guarantee is not provided as herein stated, the estimated attendance figure automatically becomes the client's guarantee and charges will be made accordingly. All events are rain or shine, on tournament date. Unless the course is closed.

GRATUITY: There will be a gratuity charge of 20% for all Food & Beverage items.

TAX: Tax is included in all tournament package prices, however, there will be a 11.5% (6.0% state of VA + 5.5% meal tax in state of VA) tax charged on all additional Food & Beverage packages.

# Golf Tournament Services Agreement

## CLEAN UP

The client is expected to remove, from the premises, all the equipment décor and supplies immediately following the event, and there upon to restore the premises to an orderly condition. We are not able to store belongings and are not liable for any items left on the premise.

Storage, early delivery, or late pick up of rental items at the Chesapeake Golf Club venue should be pre-approved.

## DÉCOR RESPONSIBILITY

Specialty, centerpiece, and ceremony décor is the responsibility of the event client. Chesapeake Golf Club has preferred vendor décor specialist we can recommend!

It is the responsibility of the event host to provide any supplies required for their décor.

No use of silk flowers petals, rice, bird seed, confetti, glitter, or sparklers are allowed inside or outside the facility.

Decorations may not be hung from any electrical fixture (including lights) or fire suppression system.

No tape, nails, staples, command strips or thumb tacks may be put on the wall, floor, or patio. No adhesive material allowed on the walls or floor.

No furniture/carpets may be removed.

All candles must be in candle holders that will contain the wax. Small votive candles or battery-operated lights are permissible.

All decorations must be removed without leaving damage.

We reserve the right to charge a cleaning fee for any excessive clean up or damage done to the facility, room/surrounding areas, linen, locker rooms, and/or Out of bounds property.

## CLIENT/GUEST/VENDOR RESPONSIBILITY

The client is responsible for the behavior and actions of all event guests, vendors, and assumes financial responsibility for damages to the building, grounds and property of Chesapeake Golf Club or any 3rd part vendor or location with exception of Chesapeake Golf Club and golf club employees. Lewd behavior, sexually explicit entertainment, gambling, or any legal activity is not permitted.

The client is responsible for ensuring that minors are under continuous supervision by a parent, guardian, or designated adult within the building and on surrounding outdoor premises including but not limited to patios, gardens, lawns, and parking lot. Chesapeake Golf Club has informed host that there is a swimming pool on the property and Chesapeake Golf Club may not be held liable for any accidents/damages regarding the swimming pool.

Client assumes responsibility for the damage to, or loss of, any merchandise, gifts or property belonging to their event, guests, agents, invitees or any other event participant, prior to, during, or following the event.

Animals, except for specially trained guide dogs for the deaf or blind, are not permitted within building. Animals may participate in outside ceremonies provided they are properly housed and cared for before, during, and after the event.
